Victoria's water businesses send us submissions on proposed prices and key outcomes for their customers. We assess the submissions and make price determinations on the maximum price they can charge for their services. New prices need to be in place by 1 July 2018.

What are the changes to prices and tariffs?

Coliban Water has proposed residential and non-residential prices for its customers that will on average **go down** (before inflation) each year of the five year period from 2018 to 2023.

The majority of its tariffs are forecast to change at inflation less 1 per cent, with some exceptions including the northern pricing zones due to price harmonisation to ensure uniform variable water prices and better reflect the costs of supply for all customers.

Coliban Water has proposed to change its form of price control to a hybrid revenue cap and continue price decreases of one per cent each year (before inflation) for a total of 10 years

How will this affect your bill?

Prices and tariffs are only part of the bill. Your actual bill depends on factors such as the amount of water and services you use. Coliban Water provided us with typical bills for different customer groups and water volumes.

What are the outcomes for customers?

As part of their price submission, water businesses must propose a set of outcomes that customers will receive during 2018 to 2023. Coliban Water proposed five outcomes along with activities and targets to measure how it performs in delivering these outcomes.

Coliban Water proposes to increase the number of Guaranteed Service Levels from four to 18, including some with rebates payable to the community when Guaranteed Service Levels are not met.





What are the major works that will go on around you?

How much revenue is required from 2018 to 2023?

We require each business to tell us what revenue it will need for the next five years. This helps us understand Coliban Water's prices in its submission.

Coliban Water forecasts that it needs \$338 million of operating expenditure and \$197 million of capital expenditure to provide its services to customers over the next five years, which includes \$51 million to fund privately operated major treatment plants. To fund this, Coliban Water requires \$616 million in revenue, an increase from \$554 million during 2013 to 2018. This additional revenue will not increase prices in the next five years because of growth in population and the efficiencies Coliban Water plans to make.
