Central Highlands Water

2023 water price review | Customer fact sheet

In June 2023 the Essential Services Commission released its final decision on Central Highlands Water's price submission. The final decision completes our review of the maximum prices that Central Highlands Water may charge for its services for a five-year regulatory period from 1 July 2023 to 30 June 2028.

What are the changes to prices and tariffs?

A typical annual owner occupier water and sewerage bill for 2023-24 will be \$1,298 (including inflation), a 5.4 per cent increase from \$1,231 in 2022-23.

For each of the remaining four years prices will go up by 0.6 per cent (before inflation).



Central Highlands Water will double its funding to support vulnerable customers over the next five years. Residential and business customers can access Central Highlands Water's customer support program for assistance with paying bills.

New customer contributions for New Growth Zone water will increase by 99 per cent in 2023-24 to \$3,000, then increase gradually for the remaining years to around \$4,121 by 2027-28 (before inflation). Central Highlands Water will also introduce new customer contributions for New Growth Zone sewer, Existing Growth Zone water and Existing Growth Zone sewer.

How will this affect your bill?

Prices and tariffs are only part of the bill. Your actual bill depends on factors such as the amount of water and services you use. Estimated typical bills for different customer groups and water volumes are below.

What are the outcomes for customers?

As part of its price submission, Central Highlands Water consulted with customers to develop a set of outcomes to guide service delivery during 2023 to 2028. Central Highlands Water worked with its customers to develop three outcomes, with measures and targets to track its performance. Following our draft decision, we have worked with Central Highlands Water to expand its outcome



set to include measures and targets that reflect both core business performance, as well as measures that reflect customer preferences. This includes the addition of a fourth outcome 'reliable water and wastewater services' comprising key performance measures which continue from the current regulatory period.

Central Highlands Water's outcome commitments to its customers are:

- Customer care
- Equity
- Sustainability
- Reliable water and wastewater services

Central Highlands Water will maintain Guaranteed Service Level commitments for customers and to increase rebates to customers if guaranteed service levels are not met.

Central Highlands Water will also:

- enhance its support for customers experiencing vulnerability
- further develop partnerships with Traditional Owners.

How much revenue is required from 2023 to 2028?

Our final decision for Central Highlands Water allows operating expenditure of \$357.7 million and gross capital expenditure of **\$250.9 million** to provide its services to customers over the next five years. To fund this, Central Highlands Water requires **\$537.2 million** in revenue.
