2018 water price review | Final decision





In June 2018 the Essential Services Commission released its final decision on East Gippsland Water's price submission. The final decision completes our review of the maximum prices that East Gippsland Water may charge for its services for a five year regulatory period from 1 July 2018 to 30 June 2023.

We undertook this review under our new pricing framework that helps promote better value and outcomes for water customers. As part of this process, water businesses sent us submissions on their proposed prices and key outcomes. We assessed proposals against a legal framework established by the Victorian Government. We sought feedback from customers at multiple points throughout the price review process to inform our decision making in an open and consultative manner.

What are the changes to prices?

Overall prices for East Gippsland Water customers will **go down** (before inflation) in 2018-19, then rise with inflation until 2022-23. The decreases occur in the first year of the regulatory period, through:

- reductions in most fixed water service fees
- · reductions in variable water fees
- reductions to some trade waste charges.

The impact of these changes on bills will vary across customer groups and consumption levels.

How will this affect your bill?

Prices and tariffs are only part of the bill. Your actual bill depends on factors such as the amount of water and services you use. East Gippsland Water provided us with typical bills for different customer groups and water volumes.

Bills are indicative. 2018-19 annual bills include inflation. 2022-23 annual bills will vary with inflation.

What are the outcomes for customers?

As part of their price submission, water businesses developed a set of outcomes to guide service delivery during 2018 to 2023. East Gippsland Water has developed five outcomes, along with activities and targets to measure how it performs in delivering these outcomes.

Some of the ways East Gippsland Water plans to improve outcomes for customers include investing in water and sewerage assets to address future demand, improving awareness about its assistance for customers experiencing payment difficulty, providing a bill rebate for outdoor community recreation groups and offering grants to schools and community groups to support native revegetation projects.





Service levels and targets will be similar to past years with some changes to Guaranteed Service Levels with four new ones decided by its customer committee.

What are the major works that will go on around you?

How much revenue is required from 2018 to 2023?*

Our final decision for East Gippsland Water allows operating expenditure of **\$97 million** and gross capital expenditure of **\$62 million** to provide its services to customers over the next five years. To fund this, East Gippsland Water requires **\$170 million in revenue**, an **increase** from \$165 million required during 2013 to 2018.

This additional revenue will not increase prices in the next five years because of growth in population and the efficiencies East Gippsland Water plans to make.
