Alpine and Hindmarsh councils not compliant with rate caps

Our annual Council Rate Cap Compliance Report shows two of the state's 79 local councils exceeded the three per cent rate cap set by the Minister for Local Government.

The report also notes that Ballarat City Council and Bayside City Council did not increase their rates at all in 2025-26, and that Hepburn and Indigo shires had a higher rate cap approved by the commission.
