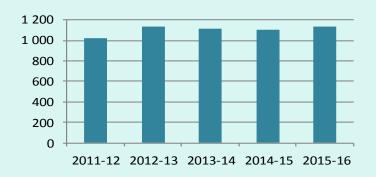

CUSTOMER OUTCOMES

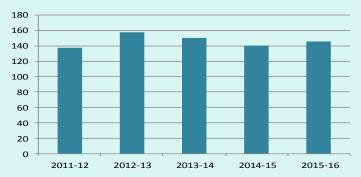
Average Household Bill (nominal dollars)

 A bill is calculated from the average household consumption of water at the actual price.



- An owner occupier's average household bill increased from \$1102 in 2014-15 to \$1132.
- Tenants who are not billed fixed charges had their bills increase from \$245 in 2014-15 to \$266.

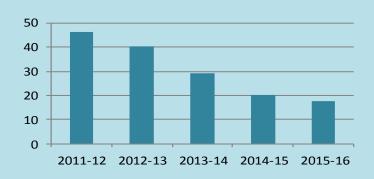

 Customers experienced an average of 18 minutes off supply (2 minutes better than 2014-15).

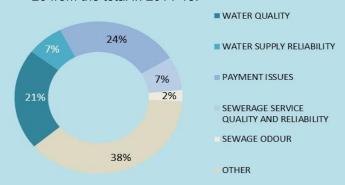


Sewer System Reliability
