Public engagement summary: Victorian Default Offer: amendment to price determination 2021

We engaged with interested stakeholders to hear and consider their views on our proposed variation to the 2021 Victorian Default Offer. The variation will take effect from 1 September 2021.

We received a total of 19 submissions. We considered these submissions in forming our final decision.

Project background

The Victorian Default Offer is a simple and trusted electricity price that is set by us, not energy companies, every year. It provides Victorian consumers access to a fair electricity deal even if they are unable or unwilling to engage in the retail market. The Victorian Default Offer also functions as the maximum price embedded network operators may charge residential and small business customers.

When we determined the 2021 default prices in November 2020, we used the Australian Energy Regulator approved network tariffs to calculate network costs for the default offer. However, the approved network tariffs for the second half of 2021 were not available.

Since then, the Australian Energy Regulator has approved the network tariffs that would apply from 1 July 2021. It also introduced new two period (peak and off-peak) time of use network tariffs that will be the default network tariff for around 400,000 legacy non-flat customers (approximately 15,000 being default offer customers), as well as new connections in Victoria.

Our final decision is to vary the 2021 Victorian Default Offer price determination to account for the new network tariffs and structure approved by the Australian Energy Regulator which will apply from 1 July 2021. This is consistent with our Victorian Default Offer methodology and current price determination.

In deciding how to amend the 2021 Victorian Default Offer price determination, we run a public engagement process to ensure the views of interested stakeholders were heard and considered.

Our consultation period was relatively short because it was urgent to align the default offer with changes in network tariff structures and prices as soon as possible after 1 July 2021. Our consultation process and timeframes were tailored to what we considered most appropriate for making the variation. This is consistent with the requirements of the Victorian Default Offer pricing order and the current default offer price determination.

Our approach also reflected the:

- 1. extensive consultation we undertook in 2020 on options for reflecting anticipated changes in network tariffs in the Victorian Default Offer
- 2. benefits of enabling new default offer tariffs to apply from 1 September 2021
- 3. relatively narrow focus of our proposed variation (focusing on network tariffs only)
- 4. treatment of network costs as a pass through in our default offer methodology.

Despite the short engagement period, we are satisfied that stakeholders had ample opportunity to provide the commission with feedback on the consultation and draft decision papers. The number of submissions we received and the level of stakeholder participation in our public forum, show this.

The engagement process has informed our decision making and we have provided a summary of how on pages 4–5 of this document. We have made our decision after considering all matters raised by stakeholders and all relevant provisions and matters we must have regard to under the Electricity Industry Act 2000, the Essential Services Commission Act 2001 and the Victorian Default Offer pricing order.

How we engaged



Key dates

- 14 May 2021: consultation paper was released. We sought views on our proposed approach to vary the 2021 Victorian Default Offer price determination.
- 20 May 2021: an online public forum was held. We explained our consultation paper, heard from stakeholders and took questions from attendees.
- 25 May 2021: submissions to consultation paper closed.
- 25 June 2021: draft decision paper was released.
- 2 July 2021: submissions to draft decision paper closed.
- 16 July 2021: final decision and amended price determination was released.
- 1 September 2021: variation takes effect.



Methodology

- We sought feedback and submissions via Engage Victoria for the consultation and draft decision papers.
- We held an online public forum.

- We invited stakeholders to email us at vdo@esc.vic.gov.au.
- We had one-on-one meetings with stakeholders.



Number of participants

- Between 14 May to 2 July 2021, we had 333 visits at our <u>Engage Victoria</u> <u>consultation page</u> by 245 visitors.
- 65 attendees at our public forum including:
 - energy retailers
 - embedded network operators
 - consumer representatives and advocates
 - government departments
 - consultants.



Number of submissions received (written, verbal)

- 19 submissions from retailers, embedded network operators, Consumer Action Law Centre, and consumers. These included:
 - 11 written submissions to our consultation paper made through our page in Engage Victoria and by email
 - 8 submissions to our draft decision paper made through our page in Engage Victoria and by email.

The Essential Services Commission is responsible for setting Victorian default offer prices. The default offers are designed to be simple, trusted and reasonably priced electricity options to safeguard customers unable or unwilling to engage in the market. On 27 November 2020, we made a final decision and price determination on Victorian default offer prices to apply from 1 January 2021 for customers on electricity standing offers.
