While PoM must submit Tariff Compliance Statements on an annual basis, many of the requirements of the Pricing Order apply over a Regulatory Period rather than annually. As PoM adopted a five-year regulatory period in the 2023-24 Tariff Compliance Statement, details of our compliance with many of the Pricing Order and undertaking requirements are set out in the 2023-24 TCS and not repeated in the 2024-25 TCS. Consequently, this document also provides cross-references to the most relevant sections of the 2023-24 TCS where appropriate (denoted as TCS24).
