We have made changes to our activity guides to clarify and update a number of requirements for lighting activities under the Victorian Energy Upgrades (VEU) program.

The updates provide program participants with guidance on how to participate in this activity, including their obligations.

Updates to lighting activities

We have released updated lighting activity guides to clarify and update the following requirements:

Clarification/update	Applies to	Rationale for the change
Clarification of licensed electrician requirements	Activities 21, 27, 34 and 35	To provide detailed guidance on what licenses must be held by electricians in undertaking lighting upgrades in response to a stakeholder query on the issue.
Addition of table detailing available lamp ballast combinations entries for installed lamp product types	Activities 27, 34 and 35	To provide participants with guidance on which lamp ballast combination are eligible for each lamp product type when creating VEECs in response to stakeholder queries on the issue.





Clarification/update	Applies to	Rationale for the change
Clarification regarding eligibility of open air car parks under activity 34 and 35.	Activity 34 and 35.	To clarify the treatment of open air car park related lighting upgrades under activity 34 and 35 in response to a stakeholder query on the issue.
Update to evidence required for car parks related space type and BCA class 7A buildings (with 7000 annual operating hours)	Activity 34	To update our evidentiary requirements to be consistent with other space types above 4500 annual operating hours by requiring additional evidence to verify the space type/building classification claim.
Clarification of required decommissioning and reconciliation evidence	Activity 34 and 35	To clarify what information must be captured on the recycling invoice and what supporting reconciliation evidence must be provided where a single activity or bulk recycling invoice is provided in response to a stakeholder query on the issue.
Clarification of minimum phone and field audit requirements	Activity 21	To clarify which phone and field audit requirements apply to specific activities.
