Dear Essential Services Commission,
Granting Powercor 'Australia' Limited (Powercor) an electricity transmission licence in Victoria would be a failure of the Essential Services Commission's primary objective under section 8 of the ESC Act, to promote the long-term interests of Victorian consumers as dominating Powercor owners - Chinese Communist Party Cheung Kong Holdings & Spark Infrastructure already have far too much control of Electricity/Gas Supply/Distribution & Hydrogen Trials/Pilots in Australia which is an absolute disaster for National Security as they are subject to the CCP's National Intelligence Law.

Spark Infrastructure also own part of TransGrid.
