This was introduced in 2016–17 to restrict the amount councils can increase their general rates and municipal charges each financial year.



Council's rating strategy 2022–23

Council applies 5 differential rates for different types of property, a municipal charge and recovers the cost of waste services using service charges. The adopted budget contains more information about rate categories and charges.

Distribution of rates increases and decreases

The applicable rate cap is applied to council's average rate. So, some individual rates increased by more and some increased by less than the applicable cap (or even decreased).



Indigo Shire Council's total revenue increased in real terms between 2018–19 and 2021–22, reflecting increases in revenue from grants.

Rates and charges, and grants were the largest sources of council's revenue, accounting for 81 per cent of total revenue between 2018–19 and 2021–22.



In terms of revenue per person (which adjusts for changes in population), revenue from grants and 'other' revenue increased between 2018–19 and 2021–22. This compares with a downward trend in revenue per person from user fees and statutory fees and fines and contributions — however both increased in 2021–22.



Indigo Shire Council's total expenditure trended upwards in real terms, despite fluctuating between 2018–19 and 2021–22. This reflected changes in all expenditure categories.

Employee costs was the largest area of expenditure, which accounted for 30 per cent of total expenditure between 2018–19 and 2021–22.



Indigo Shire Council's spending on asset renewal trended downwards in real terms, despite fluctuating between 2018–19 and 2021–22. Asset renewal accounted for the highest share of capital expenditure over this period (47 per cent).

Council's spending on new assets increased in real terms between 2018–19 and 2021–22, while spending on asset upgrades fluctuated.



Did council renew assets (such as roads, parks and buildings)?

Renewal & upgrade expenditure as a percentage of depreciation

Council's spending on renewing and upgrading assets trended downwards in real terms between 2019–20 and 2021–22, following a peak in 2019–20. Renewal and upgrade expenditure decreased below the amount of depreciation (the decline in value of council's assets caused by age and use) in 2020-21. It was forecast to increase above the amount of depreciation in 2022–23, before decreasing in 2023–24.







percentage of current liabilities)



Between 2018–19 and 2021–22, Indigo Shire Council reported an average adjusted underlying result of -18.7 per cent. An ongoing negative result suggests that, without an increase in ongoing revenue or the receipt of one-off grants, ongoing revenue may not fund the range and level of services being provided.

Council could meet its current financial obligations with a reported average working capital ratio of 201 per cent between 2018–19 and 2021–22.



Between 2018–19 and 2021–22, council reported an average indebtedness ratio of 29.6 per cent. The lower the percentage, the greater a council's ability is to repay debt from revenue it controls.
