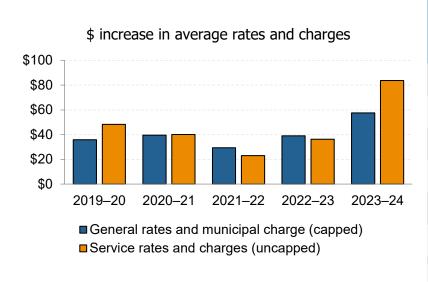

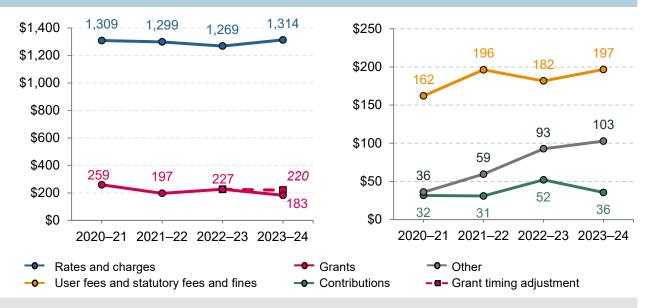

Mornington Peninsula Shire Council's total revenue increased in real terms between 2020–21 and 2023–24, reflecting increases in revenue from 'other' revenue and user fees and statutory fees and fines.

The decrease in grant revenue in 2023–24 partially reflects the financial assistance grants being received later than usual. Council would have received \$37.5 million in grant revenue if the payment was received before the end of the financial year.

Rates and charges was the largest source of council's revenue, accounting for 72 per cent of total revenue between 2020–21 and 2023–24.

In terms of revenue per person (which adjusts for population growth), council's revenue from user fees and statutory fees and fines, contributions and 'other' revenue increased in real terms between 2020–21 and 2023–24.

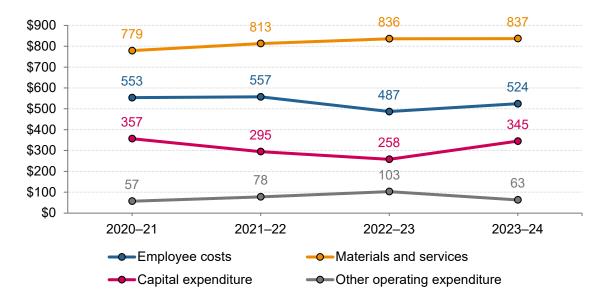

Mornington Peninsula Shire Council's total expenditure fluctuated in real terms between 2020–21 and 2023–24, reflecting changes in all expenditure categories.

Materials and services was the largest area of expenditure, which accounted for 47 per cent of total expenditure between 2020–21 and 2023–24.

Expenditure per person (2023–24 dollars)



In terms of expenditure per person (which adjusts for population growth), council's expenditure on materials and services and 'other operating expenditure' increased in real terms between 2020–21 and 2023–24, while employee costs and capital expenditure decreased.

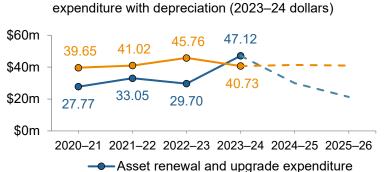

Mornington Peninsula Shire Council's spending on asset renewal trended upwards in real terms, despite fluctuating between 2020–21 and 2023–24. Asset renewal accounted for the highest share of capital expenditure over this period (45 per cent).

Council's spending on asset upgrades and asset expansion increased in real terms between 2020–21 and 2023–24, while spending on new assets declined.

Renewal & upgrade expenditure

Council's spending on the renewal and upgrade of its assets trended upwards in real terms, despite fluctuating between 2020–21 and 2023–24.

Renewal and upgrade expenditure increased above the amount of depreciation (the decline in value of council's assets caused by age and use) in 2023–24. This spending was forecast to decrease below the amount of depreciation in 2024–25 and 2025–26.

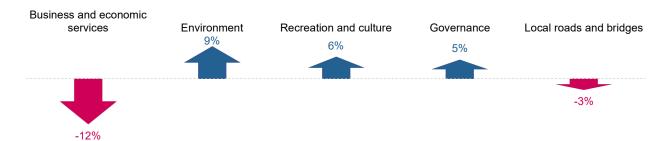

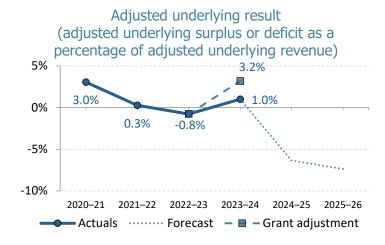

Is council operating sustainably?



Between 2020–21 and 2023–24, Mornington Peninsula Shire Council reported an average **adjusted underlying result** of **0.9 per cent**.

The average result would have been 1.4 per cent, if the timing of the financial assistance grants payment in 2023–24 was consistent with previous years.

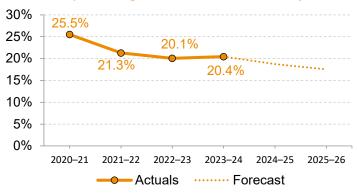
An ongoing positive result suggests there is enough ongoing revenue to continue to fund the current level of service provision.

Council could meet its current financial obligations with a reported average working capital ratio of 225 per cent between 2020–21 and 2023–24.

Indebtedness (non-current liabilities as a percentage of own-source revenue)



Between 2020–21 and 2023–24, council reported an average indebtedness ratio of 21.8 per cent.

The lower the percentage, the greater a council's ability to repay debt from revenue it controls.
