## Water Plan 2008 to 2013 - Response to Draft Determination

# **Templates**

Completed templates have been emailed to Marcus Crudden, along with an electronic copy of this covering letter.

### Regulatory Capital Expenditure

Regulatory capital expenditure has been agreed with the Commission and SKM at \$191.1M. The templates have been completed accordingly and have been emailed.

## Regulatory Operating Expenditure

Regulatory operation expenditure has been agreed with the Commission and SKM.

Two items of note are:

- Green offsets for the Goldfields Superpipe, deducted from the draft determination, have been added back as agreed with SKM this week. Coliban has yet to receive formal notification of the adjusted regulated operations cost, so have provided the table below to indicate how the regulatory operations cost in the final template has been calculated.
- Adjustments to the environmental levy have been included as per the reconciliation table below. It is anticipated that the Department of Sustainability and Environment will make further changes to the environmental contribution prior to the final decision.
   If such adjustments are required to be made, Coliban would make changes to variable water charges.

# Payroll Tax

Coliban is aware of the Payroll Tax changes announced in the State Budget of 6 May. The new changes, applicable from 1 July 2008, reduce the payroll tax rate from 5.05% to 4.95%. The impact on Coliban Water is an annual total of \$6K. Coliban considers this amount to be immaterial and has not changed its regulatory operations expense to reflect this change.

Central includes the towns of:

Axedale, Barkers Creek, Bealiba, Bendigo, Boort, Bridgewater, Campbells Creek, Castlemaine, Chewton, Dunolly, Elmore, Elphinstone, Fryerstown, Goornong, Guildford, Harcourt, Heathcote, Huntly, Inglewood, Korong Vale, Kyneton, Laanecoorie, Lockington, Maiden Gully, Maldon, Maldon-Newstead Pipeline, Malmsbury, Mandurang, Marong, Newstead, Pyramid Hill, Raywood, Serpentine, Strathfieldsaye, Taradale, Tarnagulla, Tooboorac, Trentham, Tylden, Wedderburn and Yapeen

Northern Rivers includes the towns of:

Echuca, Cohuna, Gannawarra, Gunbower, Leitchville, Mead and Rochester

Non Potable includes the towns of:

Enviro 1 includes the towns of:

Bridgewater, Epsom (Enviro Scheme only), Campbells Creek, Chewton, Echuca (Hansen St and Wharparilla Drive only), Harcourt, Huntly, Inglewood, Maldon, Marong, Pyramid Hill, Trentham, and Tylden

Enviro 2 includes the towns of:

Axedale, Boort, Dunolly, Gunbower, Leitchville, Newstead and Wedderburn

Recycled Water

Charges only apply for Central District towns.

- In its submission, Coliban proposed a specific price cap within a basket of tariffs, with individual charges within the basket being capped at a maximum change of 2%. This to allow for:
  - The intention for the Water Access Fee (base charge for a 20mm meter) to be set at \$100 at the start of the regulatory period, and be held at this level for the life of the Water Plan
  - Rochester variable price (currently an individual price) to be brought into line with the Northern Rivers pricing
  - Sewer Access Major and Sewer Access Enviro 1 to be brought into line in 2008/09 and remain the same for the life of the Water Plan
  - Rural access fees to be set at the following levels:

and to be held at that level for the life of the Water Plan.

All changes would be made within the regulatory revenue allowance for that year

## Service Standards

As a result of the draft determination, and the postponement of the completion Harcourt Recycling Scheme to a later period, Coliban advises that the Key Performance Target for Recycling will decline in the final year of the plan from 82% to 73%.
