DEAR Sir/Madam,

I AM A 79-YEAR-OLD WOMAN, A PENSIONER, AND IN EXTREMELY POOR HEALTH.

I HAVE BEEN SHOCKED TO THINK THAT OUR RESOURCES - GAS, ELECTRICITY AND WATER, HAVE BEEN PRIVATISED. WHO, EXACTLY, IS RESPONSIBLE FOR SEEING OUR RESOURCES OVERSEAS? THIS IS AN ABOMINATION, AND ITS PENSIONERS TREMENDOUSLY.

CURRENTLY, MY GAS AND ELECTRICITY ACCOUNTS ARE BOTH WITH ORIGIN ENERGY. MY GAS ACCOUNT HAS LEAPT FROM \$70 A QUARTER TO \$421 PER  $\frac{1}{4}$ !! THIS IS QUITE BEYOND ANYTHING I KNEW IN RETIREMENT. I PAY BY INSTAMENTS AT ORIGIN, BUT HOW TO FIND MONEY TO PAY THESE INCREASING ACCOUNTS FROM THE PENSION IS CAUSING A WORSENING OF MY HEALTH, ALREADY.

I AM UNDER SPECIALIST CARE FOR STENOSIS OF THE SPINE, BRONCHITIS (WHICH I AM CURRENTLY FIGHTING WITH INFLAMMATION OF THE LUNGS), ASTHMA, & I RECEIVE A 3 HOUR INFUSION AT THE HOSPITAL EACH MONTH. DUE TO THIS IMMUNE SYSTEM I HAVE SUFFERED CONSTANT ILLNESS FROM AGE 2. OSTEOARTHRITIS NEARLY TOOK MY LIFE, THEN CONSTANT ILLNESS FOLLOWED.

I AM TAKING MEDICATIONS FOR ALL MY PROBLEMS, AND THE COST OF THIS COMES FROM MY PENSION, NATURALLY. I ALSO SUFFER SEVERE ANXIETY AND DEPRESSION WHICH IS EXACERBATED BY MY SICKNESSES, AND THE COST.

MY BIGGEST PROBLEM IS HEATING IN WINTER. MY SITTING-ROOM MUST ALWAYS BE WARM. EXTRA CLOTHES ARE INSUFFICIENT IN MY CASE. A CONSTANT COUGH WARNS ME WHEN I'M TOO COLD. LAUNDRY IS DONE IN MY KITCHEN, BUT DRYING IS DONE INSIDE AS I HAVE TEARS IN BOTH SHOULDERS, AND CAN'T USE THE CLOTHES LINE OUTSIDE. I'M UNABLE TO LIFT MY ARMS.

I PRAY THAT SOME SATISFACTORY SOLUTION  
WILL BE FOUND, FOLLOWING THE IGNORANCE WHICH  
THESE GOVERNMENT MORONS HAVE EXERCISED IN  
THE FIGHT FOR GREED. THIS IS A SERIOUS  
MATTER INDEED, AND THE GOVERNMENT OF AUSTRALIA
